## **Bylaws:**

Chair and member reviewed the Bylaws for accuracy. There were housekeeping matters that needed to be changed but nothing that changed the content.

#### **Education:**

Chair and team have secured education for the rest of the year plus the education for the Oregon Society of Medical Assistants, Fall Quarterly.
