1 Oregon Society of Medical Assistants 2 Annual Report of the Bylaws Team 3 For the Period Ending April 10, 2021 4 5 The purpose of the Bylaws Team is to review the bylaws of OSMA, to make changes to the 6 OSMA bylaws when changes are approved by the AAMA House of Delegates and mandated by 7 AAMA bylaws. The Bylaws Team is also responsible for reviewing the bylaws of each Chapter 8 of OSMA, on a rotating basis. 9 10 Prior to the OSMA 2020 Annual Conference being cancelled, the Chair of this Team was involved in discussions regarding how OSMA might continue to operate without having an 11 12 annual meeting while remaining in compliance with the OSMA bylaws. AAMA CFO and Legal 13 Counsel, Donald Balasa was most helpful to OSMA in this matter. 14 15 During the past year the OSMA Bylaws Team has not met either in person or virtually. 16 17 The chair has attended OSMA Board meetings in June 2020, January 2021 and was unable to 18 attend the October 2020 Board meeting. This chair has participated in each of the meetings to 19 review and update the OSMA Board Manual to facilitate reconciling the Board Manual to the 20 bylaws. 21 22 The AAMA 2020 House of Delegates was cancelled due to the COVID-19 pandemic. The 2019 23 Delegates were called into service in August of 2020 to vote on a proposed amendment to the 24 AAMA bylaws. The amendment, which was approved, reads as follows: 25 "ARTICLE IX—NOMINATIONS AND ELECTIONS 26 SECTION 2. Elections. 27 A. Except for the 2020-2021 AAMA year, Officers and Trustees shall be elected by ballot and a 28 majority vote of the total voting power of the House of Delegates shall elect. For the 2020-2021 29 AAMA year, Officers and Trustees in office at the end of the 2019-2020 AAMA year shall remain 30 in office for the 2020-2021 AAMA year." 31 This amendment to the AAMA bylaws applies only to the AAMA BOT and to fiscal year 2020-32 2021. No changes need to be made to OSMA bylaws or to the bylaws of its component chapters. 33 34 It is an honor to serve OSMA as Chair of the Bylaws Team.
